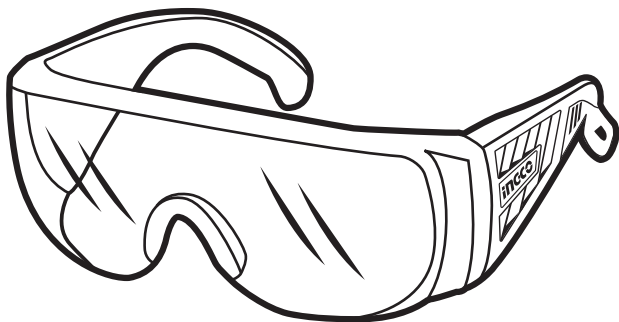

GENERAL SAFETY WARNINGS

⚠ WARNING! This eye- protection is not designed to provide unlimited protection to the eyes. Please read these instructions carefully before using for the safety's sake.

Warning which are caused at the risk analysis

- a) Failure to comply with the indicated mechanical strength (insufficient protection) - always check that your given the proper protection, in uncertainty check with the health and safety representative.
- b) Exceeding the service life (insufficient protection) - check the eye-protector before each use, for damage and life-time.

Normalization

The significance of the marking on the frame and the ocular:

Marking on the frame: SL 166 F CE, (SL=manufacturer code, 166=number of the testing standard, F=protection against high-speed particles (45 m/s), CE=Certification mark)

Marking on the ocular

SL 2 F CE, (SL=manufacturer code, 2=optical class, F=protection against high-speed particles (45 m/s), CE=Certification mark)

A note to instruct that if protection against high-speed particles at extremes of temperature is required, then the selected eye-protector should be marked with the letter T immediately after the impact letter, i.e., FT, BT or AT. If the impact letter is not followed by the letter T then the eye protector shall only be used against high speed particles at room temperature.

Declaration of the materials

The material of the eye-protection, which is directly in contact with skin, will not do any harm to the skin. But to those who are easily allergic, there might be allergic reactions.

INTENDED USE

The eye-protection can protect the eyes from the danger of mechanical collision caused by high-speed particles.

Please inspect the spectacles frequently. If the structure of the lenses is damaged or the surface is scratched, replace the product immediately, the duration depends on factors such as use, cleaning, storage and maintenance.

OPERATION

Instructions for use

The eye-protection can protect the eyes from the danger of mechanical collision caused by small flying particles. Please leave the workplace immediately if you feel dizzy or allergic caused the damage of the eye-protection.

No spare parts available

We recommend a use of the spectacle for a period of 1 year. The duration of use depends on various factors such as use, cleaning storage and maintenance. Frequently inspections and replacement if it is damaged are recommended.

If the symbol F is not common to both the ocular and the frame, then it is the lower level which shall be assigned to the complete eye-protector.

A warning that eye-protectors against high-speed particles worn over standard ophthalmic spectacles may transmit impacts, thus creating a hazard to the wearer.

MAINTENANCE AND CLEANING

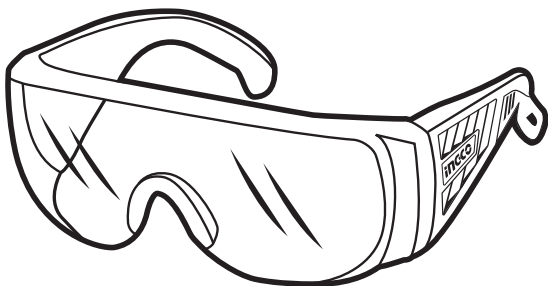
Maintenance

When you don't use the eye-protection, we suggest you put it into a clean bag or a clean and dry glasses box.

Cleaning and disinfection

A better way to maintain the eye-protection

1. Don't use abrasive materials. Using warm suds and soft cloth to wash and clean.
2. Use alcohol to disinfect the eye-protection parts which are directly in contact with the skin.
